Bringing It All Together w/the Capstone Patient - Teaching Methodology

One of the many challenges we have as ADHP educators is helping students to synthesize the vast scope of seemingly disjointed concepts into successful and knowledgeable treatment of the whole dental patient. What do vital signs, allergies, Grave's disease, prescription sedatives, diagnostic x-rays, study models, charting, crown prep set up, and infection control all have to do with each other? We typically teach these concepts independent of one another yet expect our students to understand how all of these puzzle pieces fit together. This is unrealistic; we need to help them see the big picture, but how do we do that? The Capstone Patient is a challenging yet effective and interesting andragogic approach in which our students learn to bring it all together for the wholistic care of our complex dental patients.
